







# **CLUB RULES**

# Point 1:

The registration of an archer at the club « Les Archers du Harcouët » automatically leads to the acceptance by them and their parents if they are a minor to these Club Rules.

# Point 2 :

The current rules are posted at the club, consultable on the website and a copy will be given with all new registrations.

# Point 3\_:

Any application for membership must first be accompanied by a medical certificate no more than one year old. Authorizing the practice of archery with the words « **nothing against competition shooting** » for those wishing to compete. No license will be issued without the presentation of this medical certificate of non-contra-indication. In addition, each archer must provide a registration form, downloadable from the website, completed and signed (by the legal guardian for minors).

## Point 4 :

At each season, the renewal of membership within the club of « Archers du Harcouët » will be validated after acceptance by the majority of the office..

# Point 5 :

The completion of the license will be effective when payment is made and points 3 and 4 are validated. The archer will receive their license by e-mail within a week.

## Point 6 :

The archer agrees to regularly follow the training sessions at the appointed times and scrupulously respect the safety rules (individual and collective). For minors, a record will be keep of their session, in case of absence not reported an e-mail will be sent to the legal representative .

## Point 7 :

Indoor sessions will only be possible in the presence of a member of the Bureau and to be equipped with sports shoes.

Outside shooting requires permission from a member of the Bureau who will lend them a set of keys

## Point 8 :

For the proper functioning of the sessions, the archers are asked to be present at least five minutes before each session. In the event of a delay not reported, not justified and / or repeated, the archer arrives after the warm-ups, he can be deprived of shooting for the session in progress .

## **Point 9** :

It is forbidden for archers under penalty of sanctions :

- Degrade in any way, the buildings and objects found therein (cloakrooms, toilets, etc).
- To disturb the order of the sessions.
- Smoking on the premises.
- Sweets (confectionery, chewing gum, ....) are prohibited during sessions.
- Any act of abuse or indiscipline against another member or coach will be immediately sanctioned.

#### Point 10:

Any damage to the equipment will be charged. When leaving, all archer must return the equipment and clothing loaned by the association under pain of prosecution.

#### Point 11:

The minor archers must be accompanied to and from training sessions by a parent or responsable and then entrust them to the club representative. Parents who can not accompany their children, must sign a release relieving all responsability from the club representative of the association for any event occurring to their child travelling to or from the session.

#### Point 11A :

Any disruptive archer may be temporarily excluded from the next training session by a club representative. After three exclusions they will be banned until the end of the season.

#### Point 11B :

During training sessions, laptops, smartphones ... must be either turned off or set to vibrate under penalty of confiscation until the end of the session.

#### Point 12:

The club representatives will not be able to wait for the parents to pick up their children. After 15 minutes, the children will be entrusted to the gendarmerie.
